### There's no need to worry

Leaving a gift in your Will, or making a one off donation can make a huge difference to the Technicians throughout the Industry. But in case you have any lingering questions before you read on, here are a few points worth remembering.

### Family can still come first

You don't have to choose between looking after your loved ones and protecting supporting your Industry. You can use your Will to do both – for instance by leaving a gift to the ABTT after friends and family have been taken care of. Every gift, no matter how big or small, has the powerto make a real and lasting difference.

### Your Will, your wishes

Making a Will is easy to put off, but it's the only way to be sure your wishes are carried out. Without one, you may leave your loved ones facing uncertainty. And of course, there'll be no way to ensure your desire to support the Theatre Industry continues.

### **Good financial sense**

Leaving a gift to charity in your Will can reduce the amount your estate pays in Inheritance Tax, meaning you can make an even greater difference to your loved one.

### Easing the pressure

Once you've made a Will, you and your loved ones can feel secure; and you can enjoy peace of mind knowing your wishes will be carried out.

# LEAVING A LEGACY: WHAT TYPE OF GIFT?

First you'll need to decide which type of gift you'd like to leave.

With a residuary gift, you can leave the remainder of your estate, or a percentage of it, once family and friends have been provided for.

This is the type of gift many supporters choose to make, because it has the added benefit of keeping its value over time - it isn't affected by inflation. With a pecuniary or cash gift, you can specify a particular amount of money you wish to give.

We would encourage you to leave a gift that can be used wherever it is most urgently needed at the time it comes to us, but we understand that you may wish for your gift to benefit an area of our work that's important to you.

### Making a will for the first time

Before visiting your solicitor it's a good idea to make a list of everything you own (assets) including property, money, cars, jewellery and other possesions and a list of everything you owe (liabilities) including your mortgage and any other loans.

Then decide who you want to include in your will, including family, friends and charities. Finally you'll need to appoint executors who will carry out the instructions in your will.

We reccomend using a qualified solicitor to make a new will or to amend an existing will.

You can find a solicitor in your local area using the Law Society's website. We are always happy to help you with any queries you may have about your gift.

### If you already have a will

Best advice says to look at your will every five to ten years and make sure it still reflects your wishes.

If you have an exisiting will and would like to make a few minor changes, such as including a gift to the Association of British Theatre Technicians, you may find a codicil form a simpler option than re-writing the whole. A codicil enables an update or alteration to your existing will.

We reccomend you ask your soliciotr for further information on this and to prepare and check it is legally valid, and to make sure that it is stored together with your will.



### Leaving a gift to the Association

If you decide to leave a gift to the ABTT, your solicitor will need the Charity name, address and registered charity number. You may find the folowing wording useful:

We're always extremely grateful to recive gifts in wills. You can ask for your gift to be kept anonymous, otherwise all legacies over £500 will be acknoweldged in our Annual Report and Accounts. Every gift makes a difference and we are always happy to discuss ways in whih we can recognise your pledge.

### **Inheritance Tax**

Legacies to your spouse, civil partner or a charity such as the ABTT are free of inheritance tax.

If you leave 10% or more of the net value of your estate to charity in your will, your estate can pay inheritance tax at a reduced rate of 36% instead of 40%. This may mean that fmaily and friends receive more than they would have otherwise while your favourite chairties also benefit.
